ANNEXURE - I
General Conditions

1. The College should strictly adhere to the eligibility conditions prescribed by the University / Government in admitting candidates for the courses offered and also to the said courses.
2. The College should not admit students over and above the strength sanctioned by the University.
3. No amount should be collected from the students in excess of the fees prescribed by the University / Government or donations for appointment of persons for both teaching and non-teaching positions.
4. College should adhere to the Tamil Nadu Government Reservation Policy in admitting candidates and appointment of staff.
5. There shall be no financial commitment on the part of the State Government of University on account of the courses being started by the college.
6. The College should pay salary to the teachers as prescribed by the Government / UGC.
7. The College should provide space and facilities to the University to conduct examinations and for other academic purposes as and when required.
8. The Course noted above has only be granted as Self Financing Course.
9. The students shall be permitted to appear for the First-Semester examination only after 90 working days from the date of receipt of this affiliation order.
10. The management should get the Continuance of affiliation for the above said courses every year.
11. The management should obtain the approval from the University for the appointment of teaching staff.
12. The management should select the Optional / Ancillary Subject for the above courses in consultation with the Controller of Examinations of the University.
13. Approved Syllabus can be had from the Board of Studies Section of this University.

ANNEXURE - II
Specific Conditions

1. **The management should complete the on-going construction work in the second floor for Seminar Hall and Auditorium before this academic year and properly furnished.**
2. **The management should be added the models and maps and instructional aids with more relevance to the B.Ed. curriculum.**
3. **The management can ahead for digital library and enrich the library with more number of reference books and educational journals.**
4. **The Examination will be conducted only after the completion of minimum required number of working days from the date of the order of the affiliation.**
5. **Another inspection commission will be visited at the end of the first year.**
