I am by direction to inform you that, the meeting of the Syndicate of this University was held on **08.10.2021**. The syndicate has considered your college inspection report for Continuation of Provisional Affiliation and granted the order to the academic years from 2021-2022 to 2023-2024 for offering B.Ed degree programme in your College within the following conditions.

In this Connection, as per the TNTEU Norms, the Management of the College shall remit the affiliation fee of Rs.100000 lakhs by the online payment made through University portal and also requested to rectify the following deficiencies within the stipulated time prescribed in this Communication.

List of Deficiencies

- 1. Pollution Control Certificate from concerned authority for current period.
- 2. Qualification approval of the 2 teachers are not available.
- 3. Last three months' Salary of the faculty through ECS (Electronic Clearing System) for B.Ed/M.Ed degree programme(s).
- 4. Land Area, whether Wet or Dry Land (Wet Land Conversion Certificate issued by Directorate of Town and Country Planning in case if it is Wet Land as per the new Section 47(A) in the Tamil Nadu Town and Country Planning Act 1971, vide notification in the Tamil Nadu Government Gazette dated 01.01.2011 is not furnished.
- 5. Certificate under Section 37(B) of Tamil Nadu Land Reforms (Land fixation and Ceiling) Act 1961, vide notification in the Tamil Nadu Government Gazette dated 10.06.2010 is not furnished.
- 6. Documentary evidence for payment of Infrastructure and amenity charges as per Tamil Nadu Gazette Notification regarding Levy of Infrastructure and Amenities Charges Rules 2008, vide notification in the Tamil Nadu Government Gazette dated 26.01.2008.
- 7. Other deficiencies mentioned in the CPA order.

In this regard, the Management of the College is further requested to submit an Undertaking in the given format by using Notarized affidavit (in aRs100/- Non Judicial Stamp Paper) assure to rectify the above deficiencies within <u>Six Months</u> from the date of issuance of this communication.

The University will be send the affiliation order of concerned College only by Speed Post not by in person only after receiving both the online payment receipt copy for prescribed affiliation fee and Undertaking form by post. (As per the Resolution by the Syndicate)

It is also informed that, as per the Syndicate resolution, the colleges having the affiliation order for the academic year 2021-2022 will be permitted to upload the admitted students' details to the University database/Website.

Hence, the management is further requested to reply to this communication immediately on or before **27.10.2021** for further actions.
